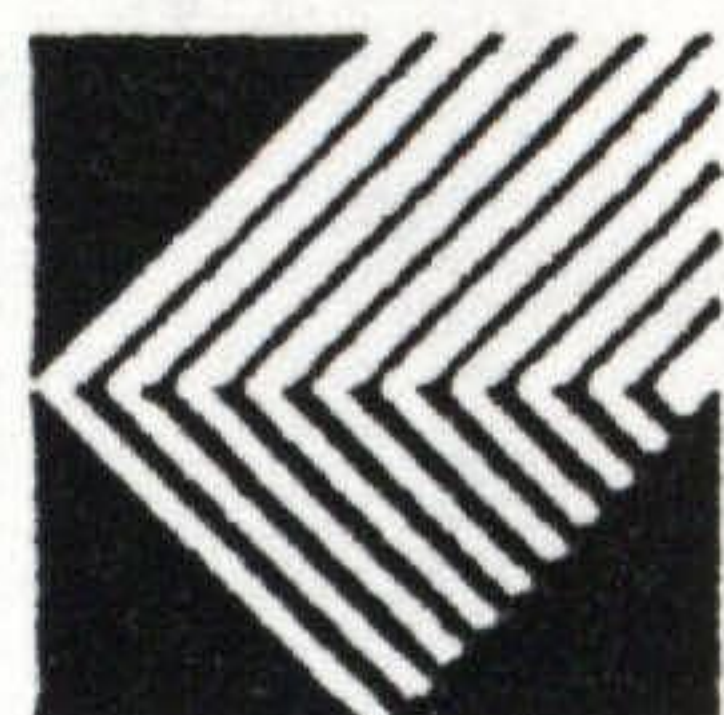

She was married to a Ben Constant who held placer claims in the Rabbit Hole area and staked the original Dreamland Claims 1 thru 4 at Rosebud. Ms. Sellers lived at Barrel Springs town for about 10 years in the 60's.
