EXHIBIT "A" --Showing formation by actual development; a 230 foot shaft and 318 foot cross-cut tunnel; pieces of Ore float was found all along the depth of this shaft to the line of contact of the local erosion and Recrushed Andesite. (See map Ex. "A".) And, at the actual seam contact, good Gold pannings was made. At 240 ft. in from Shaft, the Vein was cut thru at a point of a minor fault intrusion, from foot-wall to hanging-wall, being about 24 feet in width, with redish Talc seam on each wall end with some 6 feet of Dyke rock very much crushed in the middle; the rest of this crushed Vein matter pans about \$6.00 in smooth nugget gold. This great contact fissure that the Lucky Prince Co. claims cover by location, is situated in the Northwest corner of a great Volcanic basin, (Oatman gold belt) the floor of this basin being a series of Fre-Cambrain granite dykes, filled in by different flows of andesite. As the flow of mineral has been from Northwest to the Southeast, and take into consideration that there are more of this surface ore float and of larger pieces scattered along the trend of this vein then is found in the rest of this mining district. The comparatively circumscribed area in which this gold bearing float is found and numbrous conditions of the boulders of the formation and topography of the field in which they occur, leads inevitably to the conclusion that it is not far removed from the parent body, and here we have the MAJOR vein of this district. The development of this gold belt up to date, seems to be only in its infancy, yet millions has been paid out in dividends, within the past few years, millions more are blocked out, new mines being discovered, new mills being erected, older ones increasing their capacity. Since this district was discovered some ten years ago, it has been the Premier gold producing camp of the United States, and from all indications, with present activity, should within a few years develope into the greatest gold producing camp ever discovered.

The character of all ores in this district being a Cal-Spar-Quartz strictly a free gold milling ore. The white "spew-out" rock commonly found throughout the district, and called by miners "tuffa" which is always found in close proximity to ore bodies, I have analyzed and found to be an acid rock near Rhyolite (Kaolinized) by thermal action.

As the Lucky Prince claims are only one mile from the Colorado River this means an unlimited water supply for milling purposes for all times to come. The first Dam expected to be constructed on this river for Electric Power only, will be built just opposite this mine, which will furnish the lowest cost for power purposes.

Complying with your request for an opinion as to the merits of the property of the Lucky Prince Gold Mining Co. . I beg

The Comparatively Circumscribed area in which your gold bearing float is found, the size, number and numerous conditions of the boulders, the formation and topography of the field in which they occur, leads inevitable to the conclusion that it is not far removed from the parant body. The latter I think merely covered by the shallow drift of which there is a considerable area in the vicinity.

This view is further strengthened by the fact that the vein from which this float comes has been diligently sought by more than one prospector without results. Jesse Parmer, of Searchlight, a prospector of more than ordinary intelligence has devoted considerable time annually for several years to the search with no better fortune than the others.

It would seem therefore that in your plane to sink a shaft in. the float field its self and cross-cut when well into solid formation, you have adopted the only feasable way and, in my opinion, the prospect amply justifies the necessary cost. The size and massive structure of the float indicate that the ore body from which it came is a large one; -had it out-cropped, a mining enterprise would, no doubt, have been established on it long ago.

As in the case of the Black Range, on the Arizona side of the River, (Oatman-Gold Roads Dist.) the formation mass is of the Pre-Cambriangranitoid series and aasoin Oatman, Dist., it is cut by numerous eruptive dykes, notably of Andesite and Porphyry, some of the former being highly chloritic.
