
I would like to have a "turn-key" bid from you for the 1992 core

JOB SPECIFICATIONS

ROSEBUD PROJECT PERSHING COUNTY, NEVADA

JOB SIZE: 8,000 - 10,000 feet; hole depths will range from 600 to 1200 feet; average approximately 800 feet; vertical and angle (-60 degrees) holes; moves will be less than 1/2 mile.

STARTUP DATE: Approximately mid-March.

WORK SCHEDULE: 10 days on & 4 days off Work schedule.

LOCATION: Approximately 50 miles north of Lovelock or 50 miles west of Winnemucca, Nevada.

TOPOGRAPHY: Moderate to gentle.

ACCESS: Good - county road & dozer trail.

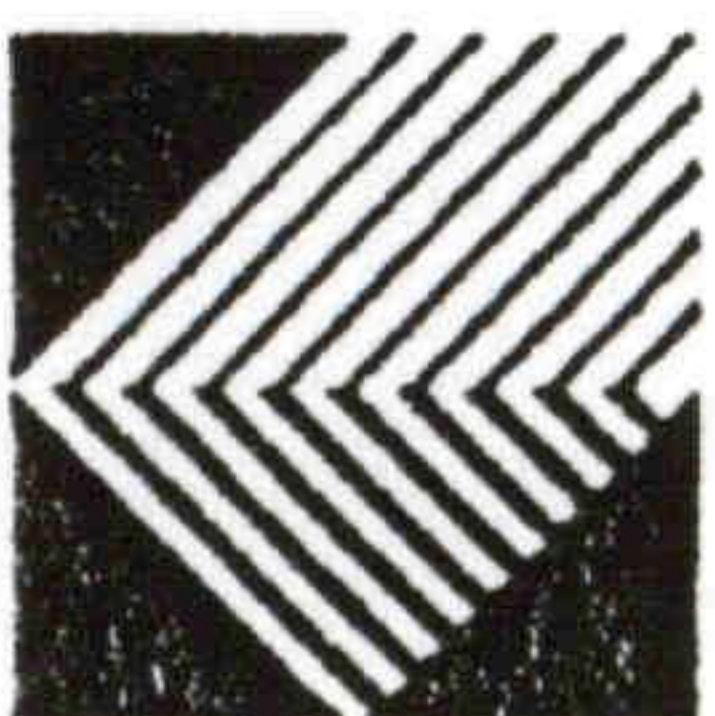
ACCOMMODATIONS: Lovelock (1 hour); Winnemucca (1 hour).

GROUND CONDITIONS: Good. Clay altered to locally silicified volcanics; gravel overburden = 0-50 feet (average < 10 feet). ground water at 100 to 200 feet;

WATER AVAILABILITY: LAC has a water supply well on site which supplies 5 to 7 gpm. An alternate water supply is approximately 10 miles (one way).

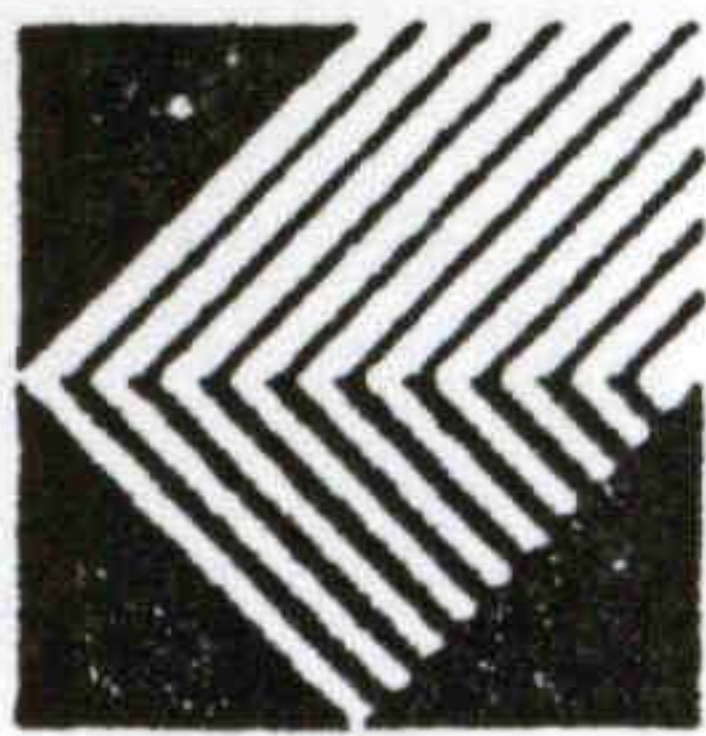
DRILLING HISTORY: +30,000 feet core drilled to date. Footage drilled per shift has ranged from 50 to 250 feet averaging 120 to 150 feet per shift.

HOLE PLUGGING: As per Nevada Regulations: Heavy bentonite pumped from T.D. to 50 feet, then plugged and cemented to collar.
